

Travis Credit Union's 75th Anniversary Giveaway

Official Rules

OFFER: Travis Credit Union (TCU) will giveaway five (5) \$750 cash prizes to participants who enter our 75th Anniversary Giveaway. Entries can be submitted online through the website, in person or via social media. Five winners will be randomly selected.

PROMOTION PERIOD: The 75th Anniversary Giveaway starts on October 5, 2026, at 7:00 am PST and ends at 11:59pm PST on October 5, 2026. The winner will be announced on Friday, October 16, 2026, on social media.

ELIGIBILITY: This giveaway is open to all TCU members who are legal residents of the state of California who are 18 years of age or older. TCU employees, their immediate family members, TCU volunteers and board members are not eligible for this promotion. Only individual persons may participate; no entry or participation from any corporation or other entity shall be accepted or considered valid. This promotion is void outside the eligibility area and where otherwise prohibited by law. By participating in this promotion, each participant accepts the conditions and terms of these official rules. All participants must meet user requirements outlined by instagram.com and must have valid instagram.com accounts in their own name.

PROCESS OF ELIGIBILITY: One entry per person. Participants may enter the giveaway once on October 5, 2026, using only one of the entry methods listed below:

- Visit any TCU branch and scan a QR code when you check in at the welcome table.
- Enter online via official TCU social media (Facebook or Instagram) posts about this giveaway
- Online at TravisCU.org/celebrating75

PRIZE: At the end of the giveaway period, TCU representatives will draw five (5) winners at random from the entries received. The potential winners selected will receive the prize only after verification of identity. No substitution, transfer or assignment of the prize will be permitted. The winner will be issued an IRS form 1099 for the value of the prize. The winner should consult with his or her tax advisor regarding the prize and applicable taxes.

WINNER NOTIFICATION: The potential winners will be contacted via social media direct message, email or by phone on Friday, October 16, 2026. The potential winner must respond within three (3) business days or the prize will be forfeited and another participant will be drawn and notified.
